The reason for this meeting is to provide a community vote regarding the COVA Brewing application for a Zoning Waiver. Scott Bateman is on the line to answer questions but in a nutshell it involves the following: Scott is buying a small slice of land around his property from the City. the property owned by the City has numerous easements from Dominion Energy, Va Natural Gas and others and they require us to apply to have the right-of-way vacated before we can move forward with the purchase.

We currently have 54 votes of support that were emailed and voted on during the meeting. I have 3 votes opposed to the zoning change. The zoning change vacates the easements.
